#### 1. Administration and Finance

#### a. Smith Physical Therapy Agreement

The Board is asked to consider a license agreement with Smith Physical Therapy + Running Academy, LLC to offer physical therapy and athletic training at Sportsplex for \$36,000 per year beginning 1/1/2023 to 3/31/2025, with the first three months of fees to be abated. Board action is requested.

## c. Amended Budget and Appropriation Ordinance 2022-12-01 for 2022

Enclosed is the Amended Budget and Appropriation Ordinance 2022-12-01 for fiscal year January 1, 2022 to December 31, 2022. The 2022 Budget was amended to reflect increases in salaries and wages, utility costs, contractual services and materials and supplies. Board action is requested.

#### d. 2022 Additional Transfer between General Fund and Sportsplex Fund

The 2022 Budget allowed for a \$120,000 transfer from the General Fund to the Sportsplex Fund. Lower than budgeted Sportsplex revenues will not be enough to cover the 2022 debt service payment on the 2018 GO Park Bonds (Alternate Revenue Source) and still allow the Fund to end the year with a surplus. Staff is recommending pledged revenues from the General Fund be used to reimburse Sportsplex for an additional amount not to exceed \$70,000 for a total 2022 transfer not to exceed \$190,000. Board action is requested.

It is requested that the Board adopt the enclosed Ordinance 2022-12-02, the Combined Annual Budget and Appropriation Ordinance of the St. Charles Park
