1. Administration and Finance

a. Recognition of Commissioner Anniversaries

Commissioners and staff will recognize service anniversaries of two Board members. Jim Cooke has served as a St. Charles Park District Commissioner for 40 years and Brian Charles has served for 10 years.

b. Tentative Amended 2023 Budget and Appropriation Ordinance

Staff requests that the Board adopt the Amended Budget & Appropriation Ordinance for the fiscal year January 1, 2023 to December 31, 2023 in tentative form. This will be available for public review for 30 days as required by Park District Code. A final version will be presented for approval at the December meeting. Board action requested.

c. Tax Levy

Staff will propose a 2023 tax levy amount that is less than a 5% increase over the prior year levy; therefore, the District does not need to conduct a "Truth in Taxation" public hearing. The formal Tax Levy Ordinance based on these assumptions will be presented at a November Board meeting for formal approval.

d. 2024 Budget Presentation

Staff will present the 2024 Budget for all Funds, excluding Capital, for Board review and comments.

e. Tentative Budget & Appropriation Ordinance

Staff requests that the Board adopt the Budget & Appropriation Ordinance for the fiscal year January 1, 2024 to December 31, 2024 in tentative form. This will be available for public review for 30 days as required by Park District Code. A final version will be presented for approval at the December meeting. A draft copy is included in the Budget Binder. Board action is requested

f. Seasonal Activity Guide Print Contract Renewal

On October 26, 2021, the Board of Commissioners approved a two-year contract with LSC Communications of Warrenville, IL to print the seasonal activity guides from Spring 2022 to Winter 2024, with an option to renew for a third year. Staff request that the Board consider renewing the contract for Spring 2024 to Winter 2025 for a cost not to exceed \$92,760.02. Board action is requested.

i. Asphalt Shingle Removal & Replacement Bid

Per the 2023 Capital Plan, bids were solicited for removal and replacement of asphalt shingles on multiple buildings at Primrose Farm and for the James O. Breen Community Park concession stand and opened on Thursday, October 19, 2023. The Board is asked to consider Premier Roofing Design, Wheaton, IL to be the lowest responsible bidder for Base Bid #1, the Concession Building at James O. Breen Community Park for \$72,000, Base Bid #2, the barn and attached structures at Primrose Farm for \$82,400 plus all five alternates for \$56,700 making a total contract price of \$211,100. Board action is requested.

j. Thornwood Grove Playground

Per the 2023 Capital Plan and the Intergovernmental Agreement with the Village of South Elgin, the Board is asked to consider the \$70,000 contribution that was

stipulated towards the new Thornwood Grove playground renovation. Board action is requested.
