

The Park District is required by The Open Meetings Act (5 ILCS 120) to disclose a list of employees expected to receive compensation greater than \$150,000 six days prior to approval of the compensation package. Within 6 business days after approving the annual budget, the Park District is required to provide a list of all employees that are expected to receive compensation greater than \$75,000. Compensation * includes salary, the cost of all employer provided health insurance programs, and allowances. The number of vacation and sick days to be granted or accrued during the next twelve months will be stated as well.
